- Kamala Municipality has allocated funds** towards the cost of **Construction of Ram Janaki Suspension Bridge Between Kamala-9 and Kamala-5,6 Dhanusha** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Ram Janaki Suspension Bridge Between Kamala-9 and Kamala-5,6 Dhanusha, Contract ID: KM/WORKS/01/2079-80**. Bidding is open to all eligible as per Section V of bidding document.
- Office of the Municipal Executives, Kamala Municipality** invites electronic bids from eligible bidders for the construction of **Construction of Ram Janaki Suspension Bridge Between Kamala-9 and Kamala-5,6 Dhanusha** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. **35000000**
 - Minimum Work experience of Successful Completion of one LSTB N Type Trail Bridge of Span greater than or equal to 184m with pile foundation.
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Kamala Municipality, Dhanusha** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (Nrs. 5000) in the Project's Rajaswa (revenue) account as specified below .

- Pre-bid meeting shall be held at **Office of Municipal Executive, Kamala** at **March 30, 2023 at 12:00 pm**.
- Electronic bids must be submitted to the office of **Office of Municipal Executive, Kamala** by through PPMO's e-GP system www.bolpatra.gov.np/egp or before **April 5, 2023 by 17:00 Pm**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **April 6, 2023 at 12:00 pm** at the office of **Office of Municipal Executive, Kamala**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs 800000**, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
